DECISION

THAT the Committee of Adjustment Secretary/Treasurer's Report DS-69/24 regarding the Clarke Sullivan minor variance be received;

AND THAT the Committee of Adjustment considered all written and oral submissions received on this application, the effect of which helped the committee to make an informed decision;

AND WHEREAS the Committee agrees that the proposed variance as presented meets Section 45.1(1) of the Planning Act and is considered minor;

THEREFORE application A-16/24 submitted by Nathan Clarke and Kelly Sullivan pursuant to Section 45 of the Planning Act for a minor variance, is granted to allow relief from Municipality of Bayham Zoning By-law No. Z456-2003, specifically:

• Section 9.2 Minimum Lot Area to permit a reduced Lot Area of 904.0 m2 whereas 1,100.0 m2 is the required minimum for lots serviced by public water and private sanitary servicing.

The variance is required as a condition of Consent £28-24 to create a new building lot.
