NOTICE OF DECISION

With respect to an Official Plan Amendment
Section 17(35) and 21 of the Planning Act

Purpose and Effect of the Official Plan Amendment

The purpose and effect of the Official Plan Amendment is to add a new site-specific subsection to permit the severance of an existing dwelling made surplus through farm consolidation.

Decision

On October 8, 2024, Elgin County Council **APPROVED** Amendment No. 37 to the Official Plan for the Municipality of Bayham. Council considered all written and oral submissions received on this application the effect of which helped Council to make an informed decision. No modifications were made as a result of submissions received.

When and How to File an Appeal

Any appeal to the Ontario Land Tribunal must be filed with the County of Elgin no later than 20 days from the date of this notice as shown above as the last date of appeal.

The appeal should be sent to the attention of the Manager of Planning, at the address shown below and must:

- (1) set out the specific part of the proposed official plan amendment to which the appeal applies;
- (2) set out the reasons for the request for the appeal; and,
- (3) be accompanied by the fee required by the Tribunal.

When the Decision is Final

The decision of the County of Elgin is final if a Notice of Appeal is not received on or before the last date for filing of a notice of appeal.

Who Can File an Appeal

Only those persons and bodies detailed in Section 17(36) of the Planning Act may file an appeal. Only individuals, corporations or public bodies may appeal a decision of the approval authority to the Ontario Land Tribunal. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

No person or public body shall be added as a party to the hearing of the appeal unless, before the plan was adopted, the person or public body made oral submissions at a public meeting or written submissions to the council or, in the opinion of the Ontario Land Tribunal, there are reasonable grounds to add the person or public body as a party.
